

# DAR ES SALAAM STOCK EXCHANGE Market Report Wednesday, 2<sup>nd</sup> December 2020

DSE recorded a total turnover of TZS 21.47 mln from 89,860 shares traded in 40 deals; and TZS 10.44 Billion from bond traded in 4 deals.

In the normal Board, CRDB counter had 81,419 shares traded at weighted average price of TZS 185 per share in 16 deal(s). JATU counter had 5,520 shares traded at weighted average price of TZS 620 per share in 10 deal(s). NICO counter had 1,600 shares traded at weighted average price of TZS 190 per share in 1 deal(s). TBL counter had 10 shares traded at weighted average price of TZS 10,400 per share in 1 deal(s). TPCC counter had 1,002 shares traded at weighted average price of TZS 2,505 per share in 6 deal(s). VODA counter had 318 shares traded at weighted average price of TZS 740 per share in 6 deal(s).

On the Government Bonds Board, a 10-year bond with a coupon rate of 11.44% and a face value of TZS 8.00 bln was traded at 116.1874% in 1 deal(s) while a 20-year bond with a coupon rate of 15.49% and a face value of TZS 1.11 bln was traded at prices of 103.2794%, 104.2001% and 105.3425% in 3 deal(s) There was no activity in Corporate Bonds segment
