

DAR ES SALAAM STOCK EXCHANGE Market Report Wednesday, 30th December 2020

DSE recorded a total turnover of TZS 7.98 mln from 18.269 shares traded in 34 deals; and TZS 0.33 Billion from bond traded in 8 deals.

In the Normal Board, CRDB counter had 14,067 shares traded at weighted average price of TZS 190 per share in 12 deal(s). DSE counter had 470 shares traded at weighted average price of TZS 880 per share in 5 deal(s). JATU counter had 1,560 shares traded at weighted average price of TZS 2,720 per share in 7 deal(s). NICO counter had 2,010 shares traded at weighted average price of TZS 190 per share in 2 deal(s). NMB counter had 20 shares traded at weighted average price of TZS 2,240 per share in 2 deal(s).
