DSE recorded a total turnover of TZS 18.68 mln from 10,317 shares traded in 28 deals; and TZS 13.62 Billion from bond traded in 7 deals.

In the Normal Board, CRDB counter had 2,685 shares traded at weighted average price of TZS 200 per share in 7 deal(s). DSE counter had 1,500 shares traded at weighted average price of TZS 880 per share in 2 deal(s). JATU counter had 4,335 shares traded at weighted average price of TZS 3,260 per share in 9 deal(s). NMB counter had 100 shares traded at weighted average price of TZS 2,240 per share in 1 deal(s). SWIS counter had 9 shares traded at weighted average price of TZS 1,160 per share in 3 deal(s). TPCC counter had 688 shares traded at weighted average price of TZS 2,500 per share in 4 deal(s). VODA counter had 1,000 shares traded at weighted average price of TZS 740 per share in 2 deal(s).

On the Government Bonds Board, a 20-year bond with a coupon rate of 15.49% and a face value of TZS 13.26 bln was traded at prices of 100.0000%, 101.0000%, 101.9575%, 103.6604% and 104.5164% in 7 deal(s).
